ESU 7 serves students, ages birth to 21 in school districts of seven counties from its offices in Columbus. We walk **Behind** our schools to keep them moving, **Beside** them to help them stay focused and on track, and far enough **In Front** of them to not only see where they are going, but to anticipate their needs.

ESU 7 delivers comprehensive professional development support and technical expertise in the realms of curriculum, instruction, assessment, standards, and continuous improvement. Is dedicated to delivering comprehensive technology support and services, encompassing consultation, technical assistance, training, and proficiency enhancement in both hardware and software domains. The ESU 7 Migrant Education Program is a Regional project which covers 33 counties in eastern Nebraska.

The ESU 7 main offices sit in the heart of the seven counties and 19 school districts the ESU serves, all of which receive support and services in some capacity. ESU 7 covers 3,500 square miles of rich farm ground and thriving communities. The 19 school districts within ESU 7 range in size from 172 students Pre-K to 12th grade, to over 4,100 students. ESU 7 services 12,650 students, 1,070 teachers, 63 principals and 19 Superintendents alongside a workforce of 104 ESU 7 employees. ESU 7 encompasses 6 of Nebraska’s 49 legislative districts as well.
