Summer-Eddyville-Miller Schools is located in rural Dawson County, with the district boundaries also including parts of both Custer and Buffalo counties.



S-E-M offers a wide variety of classes including college classes through Central Community College via distance learning. The district added a 5,000 square foot weight room that also functions as a community fitness center in 2020. The current enrollment is 216 students.

Students at S-E-M are able to participate in a number of extracurricular activities that are all strongly supported by the community. The athletics available include football, volleyball, basketball, cross country, wrestling, and track. Activities available include FFA, Speech, One Act, Quiz Bowl, Speech, Band & Music, eSports, and Student Leadership opportunities.

The school is located in Sumner, which is about 35 miles northwest of Kearney. The district also encompasses the communities of Eddyville and Miller. Sumner is situated in the Platte River Valley, which contributes to its agricultural surroundings and close-knit community atmosphere. The community has a Commercial Club and a school Foundation. Eddyville hosts a rodeo each summer, trail rides in the spring and fall, and a Mud Drag event in September each year. Additional information can be found at the link below.
