The recreation area has some of the most scenic views in the state, in addition, it has hiking trails, camping, and picnic shelters. It is also know for some of the best deer, elk, and upland game bird hunting in the country. The Wildcat Hills Shooting Sports Complex is also a new addition to the area. Organized community groups include the Banner County Historical Society, FFA Booster Club, Mat Cats Youth Wrestling, WarCats Youth Football, Wildcat Youth Basketball, and the Kimball-Banner 4-H.
