Fullerton Public Schools is a K-12 district of 303 students. The district includes the communities of Fullerton and Belgrade. Fullerton Public Schools offers a wide variety of challenging courses and has excellent technology available for all students and staff. The school offers a number of extracurricular activities including FFA, quiz bowl, music, drama and athletics. The Fullerton Warriors athletic teams compete in the Goldenrod Conference.

Fullerton is the county seat of Nance County. It is at the heart of the best hunting and agricultural land in Nebraska at the convergence of Highways 14 and 22. Fullerton is 45 minutes NE of Grand Island and 45 minutes SW of Columbus. With an active Economic Development Committee and Chamber, the community strives toward progress and development. Fullerton has a beautiful 9-hole grass green golf course and clubhouse with scenic views of the Cedar River Valley. A new outdoor recreation facility located on the Cedar River is under construction. Known as Powerhouse Park, it currently boasts 4 full-service RV pads, concrete walking trails, a boat ramp and basic camping sites. The old hydroelectric building is scheduled for renovation in 2026. The community also has a new water park and youth sports activities.
